Part (I) : Abstract

第 (I) 部分：摘要

The sale of the specified residential properties will be divided into 2 groups (namely Group A and Group B). The persons or companies interested in purchasing any of the specified residential properties are referred to below as “the registrant(s)”. Individual (whether in his/her own name or in joint names with any other parties) or company (in its own name only) registrants can only participate in any **ONE** group. Duplicated registration among different Groups will not be accepted and his/her/their registration in later group(s) will lapse automatically.

Part (II) : Registration

1. (a) The registrant(s) must **personally or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor attend** the Sales Office to submit the following at or before 5 p.m. on the day before the First Date of Sale (“the Deadline of Submission”):-

Registrants must submit the Registration of Intent online before the Deadline of Submission. Late submission will not be accepted. The Vendor shall not be responsible to anyone being unable to complete the registration at the Registration Website for whatever reason (including downtime of the server or network congestion).

- (ii) After successful submission of online Registration of Intent, the registrant shall submit the temporary reference number, barcode along with cashier order(s) and copy(ies) of identification document(s) as stated in paragraph 1(a)(ii) above to the Sales Office at or before the Deadline of Submission in order to complete the registration and obtain the Confirmation of Registration of Intent. Cashier order(s)

shall be submitted in respect of a Registration of Intent. The number of cashier order(s) shall be one. The amount of each cashier order shall be HK\$100,000. The cashier order shall be made payable to "DEACONS".

That is to say, the name of a person or a company may only appear in at most **TWO (2)** Registrations of Intent Form A **OR** a maximum of **TWO (2)** Registrations of Intent Form B, and may not appear in both a Registration of Intent Form A and a Registration of Intent Form B. Registration(s) of Intent (whether in his/her own name or in joint names with other parties) submitted from the same registrant exceeding such maximum number(s) will not be accepted. A registrant shall not include both company(ies) and individual(s).

(A) Procedures for Group A

(a) Group A Balloting

- (i) Balloting of Group A will take place on 13 March 2020. The ballot results, including "registration number", "ballot result sequence" and "the check-in timeslot for registrants" shall be posted at the 10/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong at or before 8 p.m. on 13 March 2020. The registrant(s) will not be separately notified of the ballot results. The opening hours of the show flats in the Sales Office on 13 March 2020 are from 11:00 a.m. to 5:00 p.m.

(b) Group A Unit Selection

- (i) The Group A registrant(s) (if the registrant is a company, then any one of its directors) shall **personally or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor** attend the 3/F lift lobby, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong (the “Additional Designated Venue”) on the First Date of Sale according to “the check-in timeslot for Group A registrants” in the aforesaid ballot results. The registrant(s) must bring along: -

The Group A registrant(s) whose identity(ies) has/have been verified by the Vendor shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the ballot result sequence. The Group A registrant(s) who arrive at the Additional Designated Venue at any time later than “the check-in timeslot for registrants” assigned in the ballot results shall not be eligible to select the specified residential properties according to the ballot results.

- (ii) Group A Unit Selection will commence at 9:30 a.m. at the Sales Office on the First Date of Sale. The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and Additional Designated Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time of the Group A Unit Selection. Any changes to the time of the Group A Unit Selection will be announced at the Sales Office. Registrants will not be notified separately of such changes.

- (iii) The Group A registrant(s) shall proceed to select the specified residential properties according to the ballot results in the Sales Office. Group A registrant(s) are allowed to select and purchase the specified residential properties listed in the table of “Specified residential properties that will be offered to be sold in that Group” under Part (I) in accordance with the “Criteria for selecting specified residential properties in that Group” only. Group A registrant(s) must select and purchase **at least one (1) specified residential property with saleable area of 700 sq. ft. or above or at least two (2) specified residential properties and at most four (4) specified residential properties**. If the number of specified residential properties a Group A registrant selects and purchases is more than the number of cashier orders submitted, the Group A registrant shall submit on spot one cashier order (of the payee and amount as stated in paragraph 1(a)(ii) above) in respect of each such extra specified

residential property to settle part of the preliminary deposit of that extra specified residential property (the balance of the preliminary deposit to be paid by cheque(s)). Where it is the turn of a Group A registrant to select specified residential properties that Group A registrant fails to make a selection as aforesaid (whether or not there does not remain a sufficient number of specified residential properties for fulfilling such criteria), such registrant will cease to be eligible for selection of any specified residential properties in the Group A Unit Selection.

- (vi) If a Group A registrant who has selected one specified residential property with saleable area of 700 sq. ft. or above or two (2) to four (4) specified residential properties according to the ballot result sequence on the First Date of Sale, but for whatever reason is/are unable or refuse to sign preliminary agreement for sale and purchase of any one of the selected specified residential properties, it will be deemed that the said Group A registrant has given up the right to select and purchase any specified residential property(ies) in Group A Unit Selection. In such event, such Group A registrant(s) will not be eligible to select any of the specified residential properties in Group A Unit Selection on the First Date of Sale.

The ballot results, including “registration number”, “ballot result sequence” and “the check-in timeslot for registrants” shall be posted at the 10/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong at or before 8:00 p.m. on 13 March 2020.
